



## PRIVACY POLICY

<b>FACTS:</b>	What does EF Hutton LLC (d/b/a "EF Hutton") do with your personal information?
<b>WHY?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do, here at EF Hutton.
<b>WHAT?</b>	The types of personal information we collect, and share, depends on the products or services you have with us. <b>HOW?</b>	All financial companies need to share personal information to run their everyday business. In the section below, we list reasons financial companies can share their customers' personal information, the reasons EF Hutton chooses to share information, and whether you can limit this sharing.

WHAT WE DO:	
How does EF Hutton protect my personal financial information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files, and secure record-keeping facilities within our offices.
How does EF Hutton collect my personal information?	<p>We collect your personal information when you agree to provide it. For example, when you:</p> <ul style="list-style-type: none"> <li>▪ Open an Account</li> <li>▪ Update your Account</li> <li>▪ Seek Advice Regarding Investments</li> <li>▪ Correspond with us Via E-mail, Phone, etc.</li> </ul> <p>We may also collect your personal information from others, such as credit bureaus, affiliates, and or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only the following:</p> <ul style="list-style-type: none"> <li>▪ Sharing for affiliates' everyday business purposes – information about our creditworthiness</li> <li>▪ Affiliates from using your information to market to you</li> <li>▪ Sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See <i>Other Important Information</i> section for your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account/policy unless you tell us otherwise.

## DEFINITIONS:

Affiliates	Companies related by common control or ownership. They can be financial or non-financial companies.
Non-Affiliates	Companies not related by common ownership or control. They can be financial or non-financial companies.  <i>*EF Hutton LLC does not share with non-affiliates so that they can market to you.</i>
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  <i>*EF Hutton LLC does not jointly market.</i>

## OTHER IMPORTANT INFORMATION

**Do Not Call Policy:** This Privacy Notice constitutes EF Hutton's Do Not Call Policy under the Telephone Consumer Protection Act for all consumers. EF Hutton maintains an internal Do Not Call preference list. Do Not Call requests will be honored within 30 days and will be effective for at least five years from the date of request. Telemarketing calls or prerecorded/artificial message calls may be made to residential or cellular phone numbers that appear on the EF Hutton's Do Not Call list with the appropriate consent.
